# How to apply for personal data held about you by Euler Hermes Services UK Limited / Euler Hermes Services Ireland Limited

Under the EU General Data Protection Regulation (GDPR) you, as a data subject, can ask us to confirm if we hold personal data about you; for copies of records of personal data that we hold, share or process about you; the period of time for which your personal data will be stored; the identity of any recipients of your personal data; the logic of automatic data processing, and the consequences of any profiling; and any other information relating to your personal data. This is known under the GDPR as a data subject access request.
